Profile

I graduated from the University of Melbourne in 1986 and trained in Orthopaedic Surgery obtaining my Fellowship in the College of Surgeons in 1994. During the following two years undertook basic research into the regulation of osteoblastic differentiation at the St Vincent's Institute of Medical Research, before accepting a Senior Lecturer position in the University of Sheffield Department of Surgery at the Sheffield Children's Hospital, UK.

In Sheffield I actively advanced the limb reconstruction service and developed an interest in education techniques producing a complete syllabus of video based teaching material providing a core program for education of medical students and surgical trainees in paediatric orthopaedics.

In 2008 I undertook advanced training in limb reconstruction at the Russian Scientific Institute in Kurgan Siberia and also at various European Institutes. During this time published on techniques for deformity correction and in particular techniques related to fully implantable intramedullary lengthening devices, correction of severe foot deformities and deformity correction. On return to Melbourne I was appointed to a consultant position at The Royal Children's, St Vincent's and Royal Melbourne Hospitals and became Director of Orthopaedics at The Royal Children's Hospital in 2004.

At The Royal Children's Hospital established the Limb Reconstruction Service and currently host the International Fellowship in this field, which cover the areas of limb length discrepancy, congenital and

acquired deformity, oncology, bone dysplasia and osteoarticular infection.

As Director of Orthopaedics my primary focus is on improving service delivery by exploring new models of care, particularly relating to the outpatient services. The development of the advanced practitioner in paediatric orthopaedics for physiotherapists has become an integral part of orthopaedic services delivered at The Royal Children's Hospital. In this model was now become an advanced physiotherapy practising certificate and managed by the University of Melbourne.

In 2006 I was appointed Chief of Surgery (Executive Director Surgical Services) at The Royal Children's Hospital and was made Clinical Associate Professor University of Melbourne. In the position of Chief of Surgery I have represented the hospital in the Department of Health sponsored process for integrated paediatric services and am a member of the State Trauma Committee. Within the hospital I have advocated for change, particularly in relation to peri-operative services in developing the "theatre access project" which explored all areas relating to surgical service delivery for both patients and staff. This has naturally grew into a system wide approach presented as" the way we work together" for the division of surgery.

I had primary responsibility for the design and delivery of theatre and peri-operative services in the new Royal Children's Hospital and have lead the development of integrated surgical tracking and patient safety systems including the introduction of patient safety systems into the operative rooms.

Continuing in my role as an academic surgeon I have over the last eight years developed a significant interest and expertise in the area of medical education. The use of multi media and in particular animation has led to the development of a systematic approach to informed consent for patients, that has been tested both in the private and public settings and developed into a robust delivery system that can monitor patient interaction and response to the material presented. A number of grants have been received for the development of patient education material and through this research I and the other researchers, have been able to prove conclusively that the approach that we have undertaken can positively influence patients' understanding of treatment and ultimately improve their outcome from surgery.

I have developed an online educational platform for Paediatric Orthopaedics and recently entered into a educational agreement with the British Limb Reconstruction Society to provide, expand and test the deliver of online surgical training

In 2022 we received an MRFF grant of 2.4 million dollars to establish the VicHip registry and develop a program of research for hip dysplasia to improve the diagnosis, imaging and treatment of a condition that affects children, adolescents and young adults. In 2024 I received a Foundation Grant of 1.6 million dollars for the development of research streams within the department of orthopaedics.

I have completed a Master of Surgical Education, University of Melbourne am the lead surgeon in paediatric oncology and limb reconstruction, previous Director of Surgical Training and current senior examiner in orthopaedics for RACS
